Funding Opportunities

- The EDO and Library CEO submitted an application to the Ontario Trillium Foundation Capital Grant on March 5.
- Applications were received for the Communications & Marketing Intern position, funded by NOHFC. The positions will provide support related to the development and creation of marketing materials for the Town. Activities include building social media campaigns, preparing promotional material, market research and analysis, and digital marketing. Interviews are scheduled for early April.
- Final reporting was completed by the EDO and Taxation Clerk for ICIP Transit funding, and a progress report was submitted to FedNor for the CIINO grant.

Community Improvement Plan

- Applications for the 2025 Community Improvement Plan grants are open! As we move into Spring building season, applications are accepted on a first-come, first-served basis as the funding provided is finite.
- The EDO responded to inquiries from two local business owners in March about façade improvement grants available.

Business Development

- The EDO continues to encourage all new and existing business owners to ensure their listing information is up to date. Radio ad campaign is continuing to run on an ongoing basis around other special event campaigns to advertise the directory and to bring local businesses into compliance with the Business Registration By-law 1816.
- The EDO will be completing a review of the municipal Signage Program for complete registrations and to identify where efficiencies can be made in the administrative process.
