Application: Z01-24

The purpose of the zoning bylaw amendment application is to rezone the property from R1 to R3-X to permit the development of 6 one bedroom residential units. Site specific relief is requested to permit the proposed size of each unit to be 46.45m2, whereas 55m2 is required, reduced lot frontage of 20.14 m where 25 m is required,

reduced front yard of 5.44 m where 7.0 m is required under Section 6.3 of the Zoning By-law. Site specific relief is also requested to permit 7 parking spaces where 9 are required under Section 3.23.a, permit parking in the minimum front yard under Section 3.23.d, and a 1 m projection into the east interior side yard for external stairs under Section 3.33.b of the Zoning By-law.
